

**STANDING RESOLUTION FOR AN
ALTERNATE LIFE MEMBERSHIP PLAN**

Resolved that LOS ANGELES _____ Lodge No. 42, F.&A.M. does hereby adopt the Alternate Life Membership Plan adopted at the 1991 Annual Communication of the Grand Lodge, to wit:

This Lodge will issue a Certificate of Life Membership upon the payment of the appropriate sum from the below listed schedule by any member, thereby forever exempting such a member from the payment of dues therein; provided that the dues of such a member are paid in full to the date when such payment is made; and provided further that the Life Membership Certificate shall be issued annually at the annual meeting of the Lodge; and shall in terms be limited to the annual period. Section 27020 of the California Masonic Code states that when the annual dues of the Lodge are increased, the Lodge's standing Life Membership resolution shall be deemed to have been amended without further action of the Lodge to increase the dollar amounts required for a Life Membership by the same percentage that the Lodge dues have been increased.

All amounts paid for Life Membership shall be deposited in some reputable bank, or invested in accordance with the provisions of the California Masonic Code, and only the income thereof shall be used by the Lodge, the original amounts to be forever kept and maintained for a permanent Life Membership Fund.

The Secretary of the Lodge, in making his Annual Report to the Grand Lodge, shall report the number of Life Members borne upon the roll, the amount of the fund thus created, and the manner in which said fund is invested.

This Resolution shall take effect upon its approval by the Grand Master.
